To obtain a 2015 IRS Tax Return Transcript, go to www.irs.gov/transcript. Make sure to request the "IRS Tax Return Transcript" and not the "IRS Tax Account Transcript". Use the Social Security Number (or the IRS individual taxpayer number) and the date of birth of the first person listed on the 2015 IRS income tax return, and the address on file with the IRS (normally this will be the address used on the 2015 IRS income tax return). If the parents filed separate 2015 IRS Income Tax Returns, 2015 IRS Tax Return Transcripts must be provided for both.
