If you are over the age of 65 and enrolled in the "senior plan" which is supplemental to Medicare, you do not have medical coverage for services incurred in other countries. Subject to the regulations of Medicare for supplemental plans, Medicare does not cover international medical expenses.

The College will continue to cover you for medical services outside of the United States as per your retiree healthcare benefit agreement. Should you plan to travel outside the U.S. and want international medical coverage, it will be provided to you and coordinated through the Travel Time Travel Agency. You will not be charged for this coverage. Travel Time will take care of charging the College for the cost of the insurance.
