SUMMARY

The primary purpose of this position is to complete custodial and cleaning duties for all campus buildings while interacting positively with all members of the College.

ESSENTIAL FUNCTIONS

- Clean restrooms daily
- Dust mop, wet mop, buff, strip, and wax floors
- Empty wastebaskets and collect trash
- Clean classrooms, offices, lounges, restrooms, locker rooms, hallways, and stairwells
- Clean drinking fountains
- Vacuum carpet
- Dust furniture, clean blackboards, and wipe walls
- Operate floor and carpet machinery
- Report all vandalism and needed repairs to the Shift Supervisor
- Maintain all outside entrance areas free of debris and snow
- Complete bio-hazard clean-up training and provide this service
- Other duties as assigned, such as, but not limited to snow removal, set-ups, and grounds work

NON-ESSENTIAL FUNCTIONS

- Must complete work in accordance to the Mission, Vision, and Values of the department and College
- Conduct all responsibilities in a safe manner according to regulations (OSHA, EPA, etc.)

QUALIFICATIONS

To perform this position successfully, an individual must be able to perform each essential function satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made.

Education and/or Experience

High school diploma is preferred; plus one to two years of custodial experience; or equivalent combination of education and experience.

Certificates, Licenses, and/or Registrations

This position requires a valid driver's license for business travel purposes (individual must have a US driver's license for at least three years; a motor vehicle record check will be run and the incumbent must pass the College's MVR rating system).

Other Skills, Abilities, and/or Training

- Ability to work extended hours as needed
- Ability to work weekends
- Strong organizational skills and attention to detail
- Good interpersonal skills and desire to be a team player
- Exceptional customer service skills



Excellent oral communication skills (i.e. ability to deal effectively with others, speak professionally on the phone, etc.)

PHYSICAL DEMANDS

- Rarely required to remain seated in a normal position for long periods of time
- Regularly required to walk about
- Regularly required to maintain balance while walking, standing, crouching, or running
- Regularly required to reach up and out with hands and arms
- Regularly required to talk and hear; verbally express information or instructions
- Regularly required to use hands to grasp objects, type, pick up objects, move objects, or hold objects
- Regularly required to stoop, kneel, crouch, and/or crawl
- Regularly required to climb stairs and/or ladders
- Occasionally required to lift up to 50 pounds and carry a distance of 10 feet
- Occasionally required to push and/or pull up to 50 pounds a distance of 10 feet
- Occasionally required to stand for long periods of time

VISION REQUIREMENTS

- Close vision (clear vision at 20 inches or less)
- Depth perception and the ability to judge distances and spatial relationships
- Adjustable focus
