#### **IRS Data Retrieval Tool:**

The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of the FAFSA on the web at <a href="https://studentaid.gov/">https://studentaid.gov/</a>. If you wish to utilize the IRS DRT log into your most recent FAFSA transaction, and navigate to the "Student and Parent Financial" sections.

#### How to obtain a Tax Return Transcript:

To obtain a 2021 IRS Tax Return Transcript, go to <a href="www.irs.gov/transcript">www.irs.gov/transcript</a>. Make sure to request the "IRS Tax Return Transcript" and not the "IRS Tax Account Transcript". Use the Social Security Number (or the IRS individual taxpayer number) and the date of birth of the first person listed on the 2021 IRS income tax return, and the address on file with the IRS (normally this will be the address used on the 2021 IRS income tax return). If the parents filed separate 2021 IRS Income Tax Returns, 2021 IRS Tax Return Transcripts must be provided for both.

#### How to obtain a Non-Tax Filing Confirmation:

Go to <a href="http://www.etown.edu/offices/financial-aid/forms/">http://www.etown.edu/offices/financial-aid/forms/</a> and download a copy of IRS form 4506-T. Complete sections 1-5 and check box 7. A separate form must be completed for each non-tax filer. Mail or fax the form to the applicable address/number listed on the form.

## **B) Family Information**

Number of Household Members: List everyone in the <u>parents' household</u> (e.g. the student, parents, stepparents). If parents are providing more than half of the support for individuals (e.g. parents' other children, other people living with the parents) from July 1st, 2023 through July 30, 2024, please list them as household members as well.

Number in College: Indicate any household member, <u>excluding the parents</u>, who is, or will be, enrolled at least half time in a degree, diploma, or certificate program at an eligible postsecondary educational institution any time between July 1, 2023, and June 30, 2024. Include the name of the college as well.

# 1) Identity and Statement of Educational Purpose (To Be Signed at the Institution)

The student must appear in person at **Elizabethtown College** to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID. In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.
