*Tax filers who received an extension but will have not filed their income tax return must provide proof from the IRS that they did not file for the year. Non-tax filers must provide a signed and dated statement certifying they have not filed and are not required to file a 2023 income tax return as well as sources and amount of income earned from work for each source.

How to Obtain a Tax Return Transcript:

If 2023 income tax return information for the parents was not available or could not be used, the parents should provide the institution with a **2023 IRS Tax Transcript or a signed copy of the 2023 income tax return and applicable schedules**.

To obtain a 2023 IRS Tax Return Transcript, go to www.irs.gov/transcript. Make sure to request the "IRS Tax Return Transcript".

B. Family Information

D. Identity Confirmation

You must complete the Identity and Statement of Educational Purpose. You can either complete the sections in front of a member of the Elizabethtown College Financial Aid Staff (page 3) or in front of a Notary (page 4). If you choose to complete these sections in front of a Notary, the Notary must complete the Certificate of Acknowledgement.

DO NOT complete these sections without a member of the Financial Aid Staff or a Notary being present.

1. Identity Confirmation (To be Signed at the Institution)

The student must appear in person at Elizabethtown College to verify his/her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issues ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID. In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.

2. Identity Confirmation

(To be Signed in the Presence of a Notary)
