COURSE DESCRIPTION

This course is designed to help students understand power and authority as discerned, covenanted and practiced by the Church of the Brethren for fulfilling meaningful missional ministry at all levels of the Church. Through reading, research, and class input and sharing, students will be enabled to understand the ecclesiology and polity of the Church of the Brethren. Included in this course will be the study of the relationship between the cultural context and organizational patterns of congregations and how polity is established to guide leadership and congregations in being true to their Pietist and Anabaptist traditions while striving to be relevant, vibrant and healthy for mission.

COURSE OBJECTIVES

- 2. Articulate an understanding of ecclesiology in the Anabaptist and Pietist traditions in general and the Church of the Brethren in particular.
- 3. Identify and understand the changing nature of organization and polity in the Church of the Brethren based on cultural context and organizational patterns of congregations that are true to the values of our tradition and will continue to give purpose and relevance to our existence.
- 4. Gain insights about how our Congregational Polity supports a missional understanding of the practice of ministry.
- 5. Develop insights and skill in the practice of Servant Leadership, which fits the style of leadership that best supports positive health and growth within a congregation.
